## Minutes of the Meeting to review the Progress of WDC-PMKSY 2.0 held on 18<sup>th</sup> January, 2023 at the Conference Hall, Bhumi Sangrakshan Bhavan, Assam Guwahati-5 in presence of the Hon'ble Chairman, SLNA, WDC-PMKSY

The meeting was chaired by Shri Ravi Shankar Prasad, IAS, Additional Chief Secretary to the Govt. of Assam, Soil Conservation Department & etc. and Chairman, SLNA, WDC-PMKSY, Assam.

- 2. Smt. Pallabi Phukan, ACS, Additional Secretary to the Govt. of Assam, Soil Conservation Department & CEO, SLNA & officials of SLNA welcomed the Chairman, SLNA, WDC-PMKSY, Assam and start the meeting as per the agenda.
- 3. A PPT on the status of the progress of WDC-PMKSY 2.0 was presented to the Chairman in detail by the IT programmer of SLNA.
- 4. Installment wise Fund received by DoLR is shown in the slides. In this regard, Chairman suggested for clarity, financial year wise report should be prepared. Further, Physical Progress may be highlighted in percentage.
- 5. Regarding Physical progress of Production System, it has come to the notice that some of the districts have not completed any work till now. In this regard, Chairman suggested to CEO that poor performed districts should be highlighted and a letter should be issued to the concerned project managers.
- 6. Chairman, SLNA also discussed about the fund release procedure from PIA to WC level. In this regard, he suggested to issue an SOP to the districts on release of installments from PIA to WC level.
- 7. A DO letter would be sent to the concerned Deputy Commissioner & Chairman, WCDC of the poor performing districts to take actions to expedite the works from Addl. Chief Secretary. Draft should be put up accordingly.
- 8. Chairman also suggested SLNA to initiate process for empaneling agencies for documentation viz. Photography, Videography & Advertisement under WDC-PMKSY 2.0.
- 9. Chairman, SLNA instructed to find out whether there are other committees of Water Resource, Public Health Engineering or any other Departments existing in the project area of WDC-PMKSY 2.0 for initiating convergence.
- 10. Chairman suggested to form a mechanism to review the performance of the contractual employees of SLNA for different levels. Different channel should be proposed at all 3 levels. The meeting ended with a Vote of Thanks to the chair.
